

**ORDINANCE NO. 2022-01**

**ORDINANCE AUTHORIZING DISPOSAL/SALE OF PERSONAL PROPERTY (Illinois Park District Code 70 ILCS 120 5/8-22)**

WHEREAS, the Tolono Park District in Champaign County, Illinois, is a district organized and existing under the Park District Code of the State of Illinois, as amended; and

WHEREAS, Section 8-22 of the Park District Code provides: "Whenever a Park District owns any personal property that in the opinion of three-fifths of the members of the board then holding office is no longer necessary, useful to, or for the best interests of the park district, three-fifths of the park board then holding office, at any regular meeting, by ordinance, may authorize the conveyance or sale of that personal property in any manner that they may designate, with or without advertising the sale." and, WHEREAS, the items listed on the Exhibits attached hereto are no longer useful to the Tolono Park District.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Tolono Park District in Champaign County, Illinois, that staff is authorized to use one or more of the marked alternatives to dispose of the items listed on Exhibits attached hereto:

\_\_\_\_\_ Put the items listed on Exhibit up for auction with other local units of government and junk any items not sold.

\_\_\_\_\_ Arrange for the items listed on Exhibit \_\_\_ to be sold on consignment by an auctioneer and junk any items not sold.

\_\_\_X\_\_\_ Attempt to sell / recycle the items listed on Exhibit \_B\_ and junk any items not sold.

\_\_\_X\_\_\_ Dispose the items listed on Exhibit \_A\_.

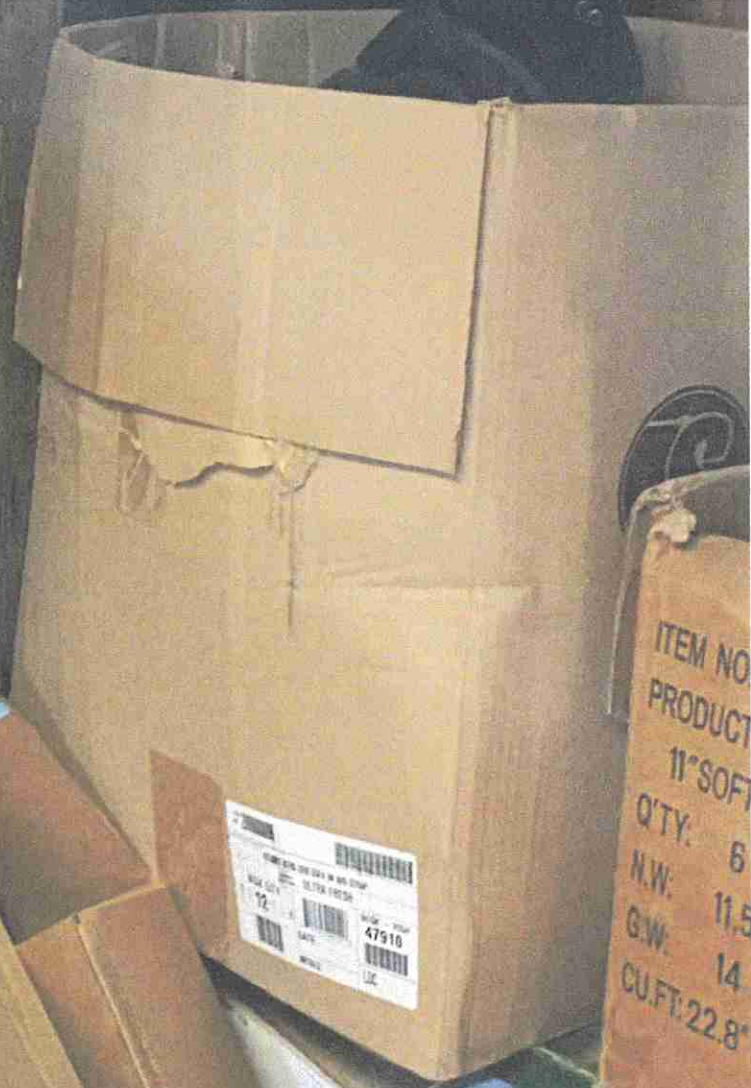
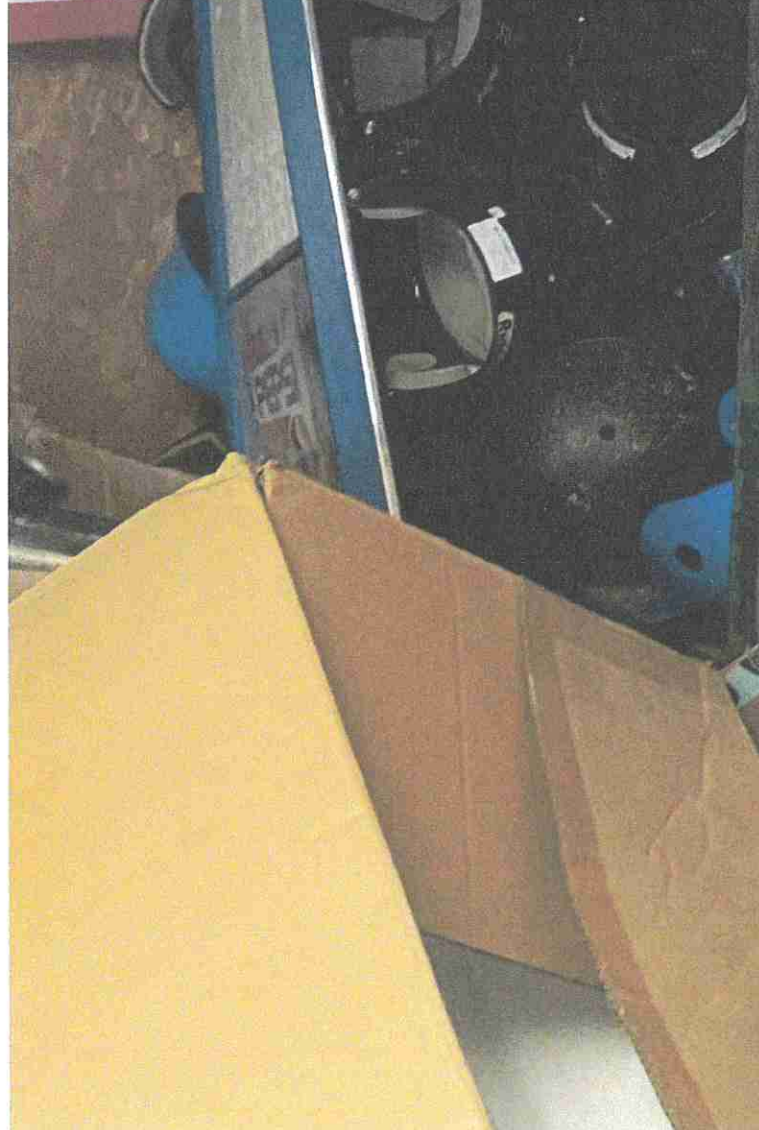

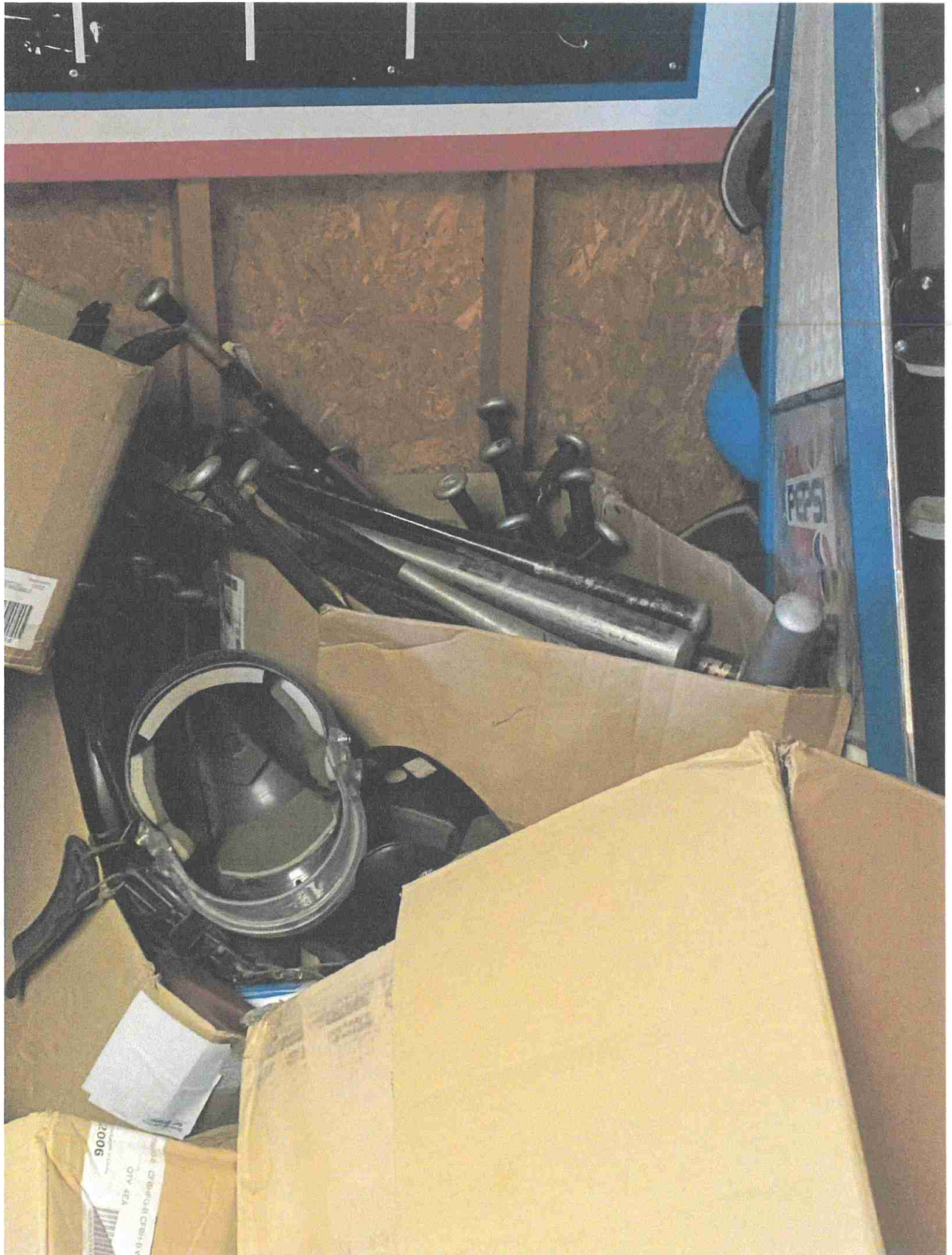
