**AN ORDINANCE AUTHORIZING THE DISPOSITION  
OF SURPLUS PROPERTY**

**WHEREAS**, the Tolono Park District, Champaign County, State of Illinois (the "Park District") is a duly organized and existing Park District created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Park District Code, and all laws amendatory thereof and supplementary thereto with full powers to enact ordinances for the benefit of the residents of the Park District and the Park District previously enacted the Park District Code; and

**WHEREAS**, the Tolono Park District, Illinois ("Park District") has the authority to declare property to be no longer necessary to the best interest of the Park District and to authorize the disposal of such property in such manner as the Park District may designate; and

**WHEREAS**, the personal property itemized in the list attached hereto and incorporated herein as Exhibit A has been determined to be no longer necessary to the best interests of the Tolono Park District.

**NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE PARK COMMISSIONERS  
OF THE TOLONO PARK DISTRICT AS FOLLOWS:**

Section 1: The Park District hereby declares that the personal property itemized in the list and pictures attached hereto and incorporated herein as Exhibit A, Exhibit B, Exhibit C, Exhibit D, and Exhibit E is no longer necessary to the best interest of the Park District and is otherwise determined to be surplus and that such property may be sold, traded or recycled by the Park District President or their designee.

Section 2: This Ordinance shall take effect and be in force from and after its passage and publication in pamphlet form as provided by law.

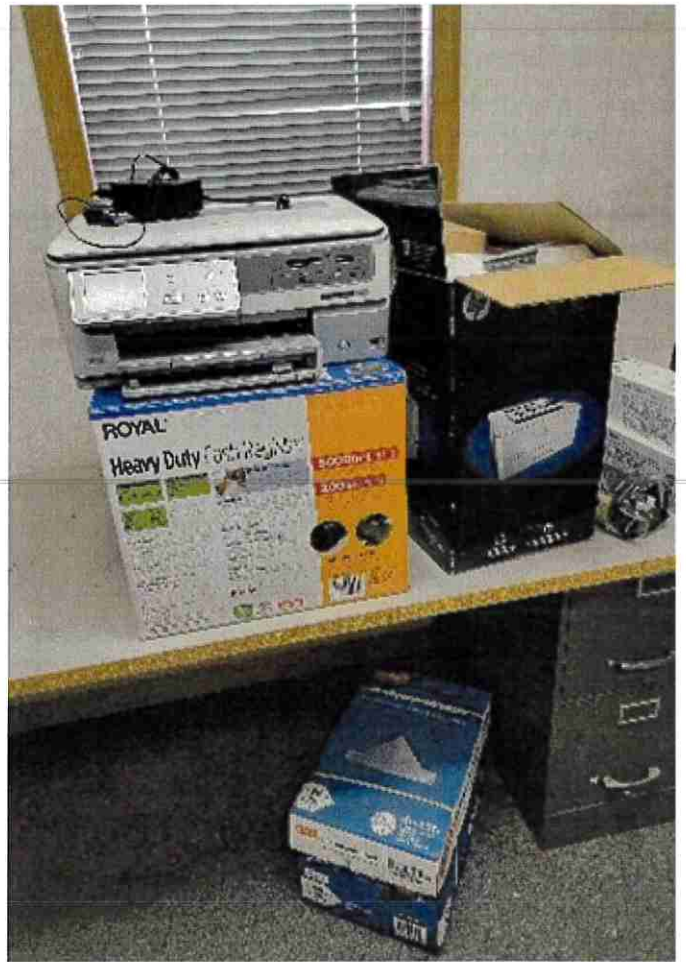




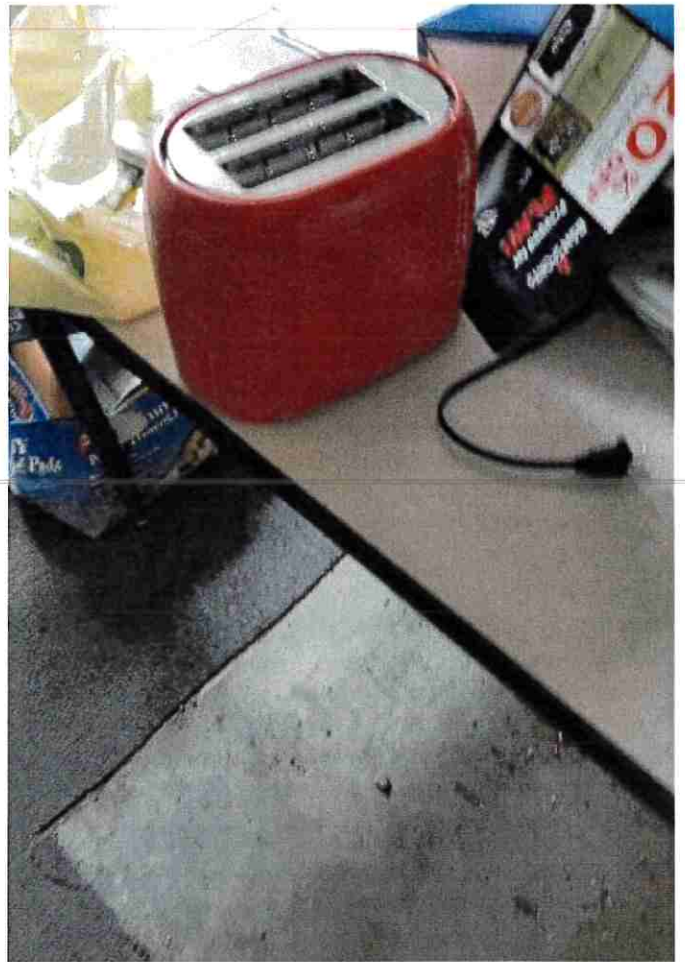


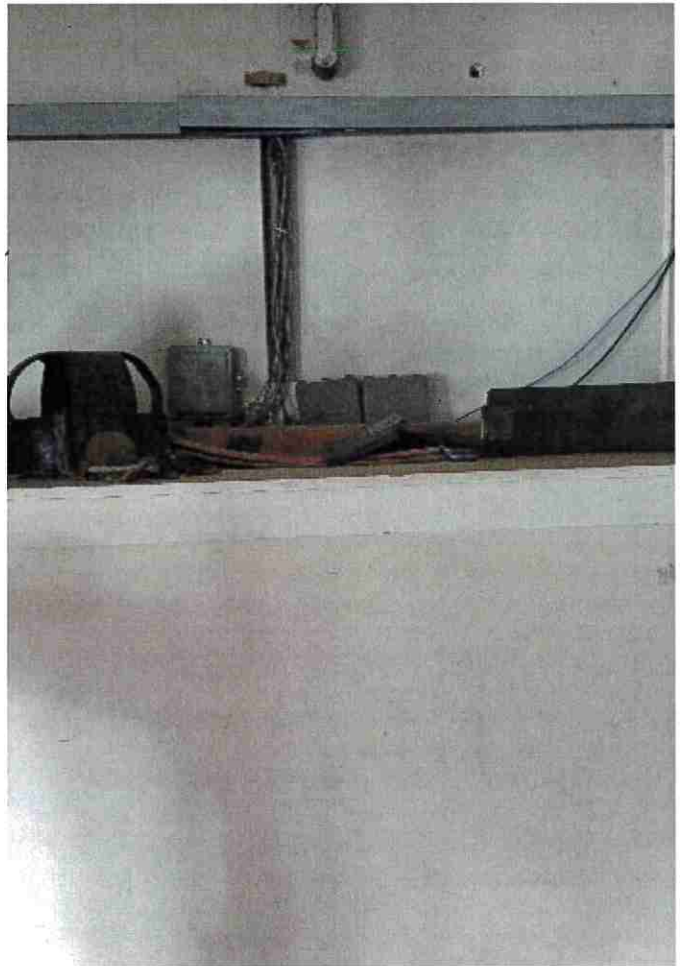
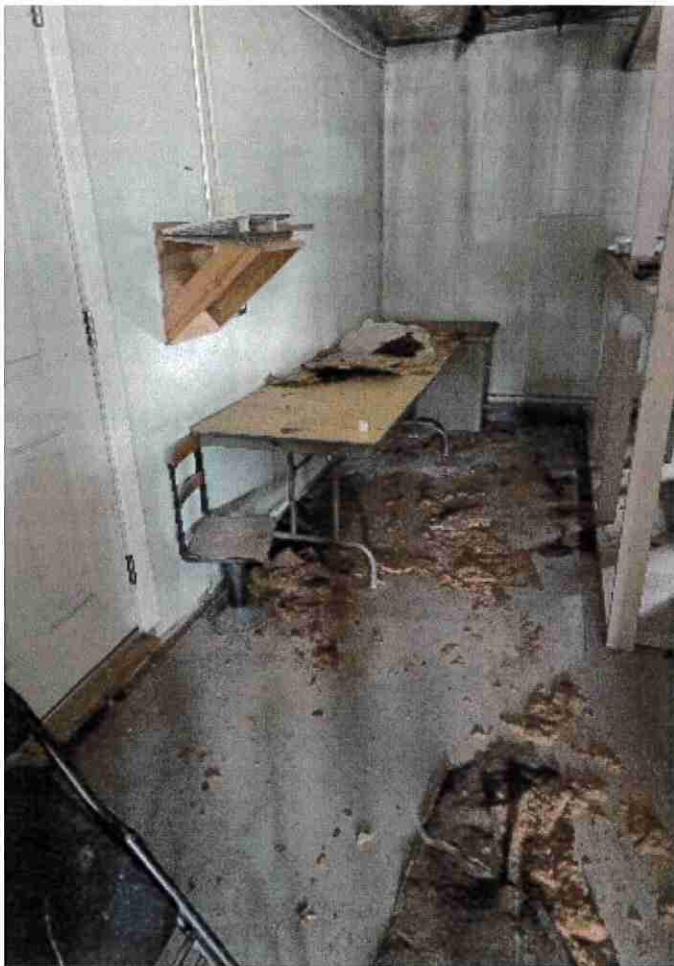
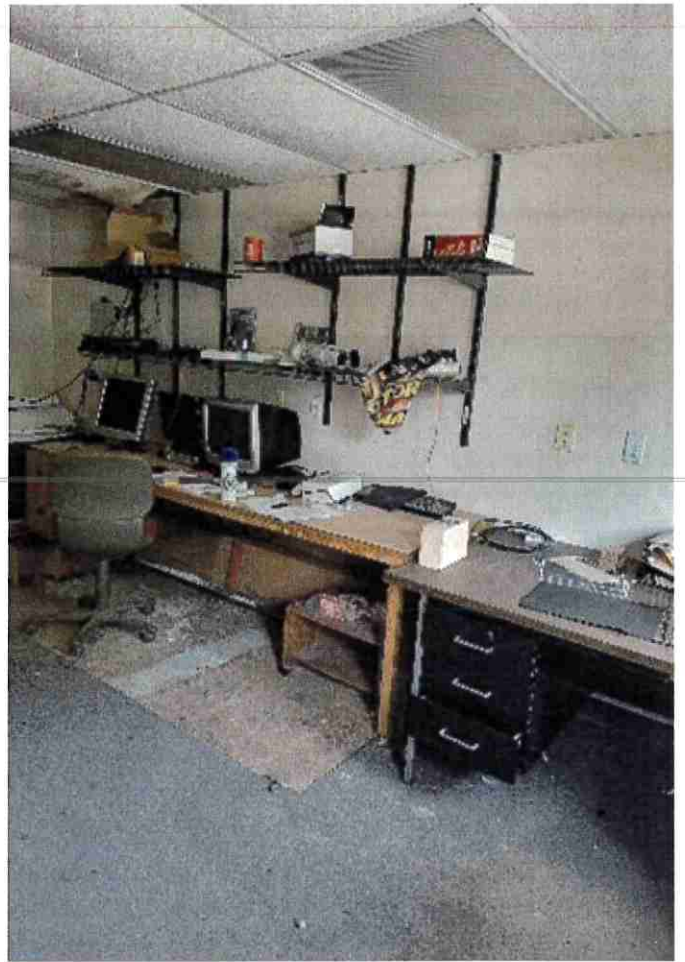
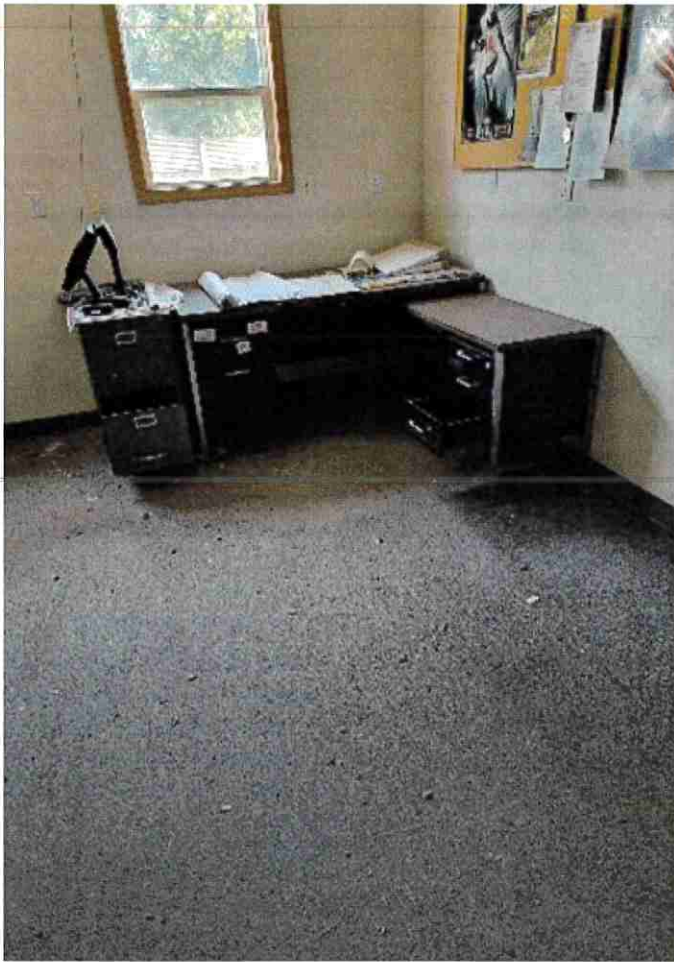




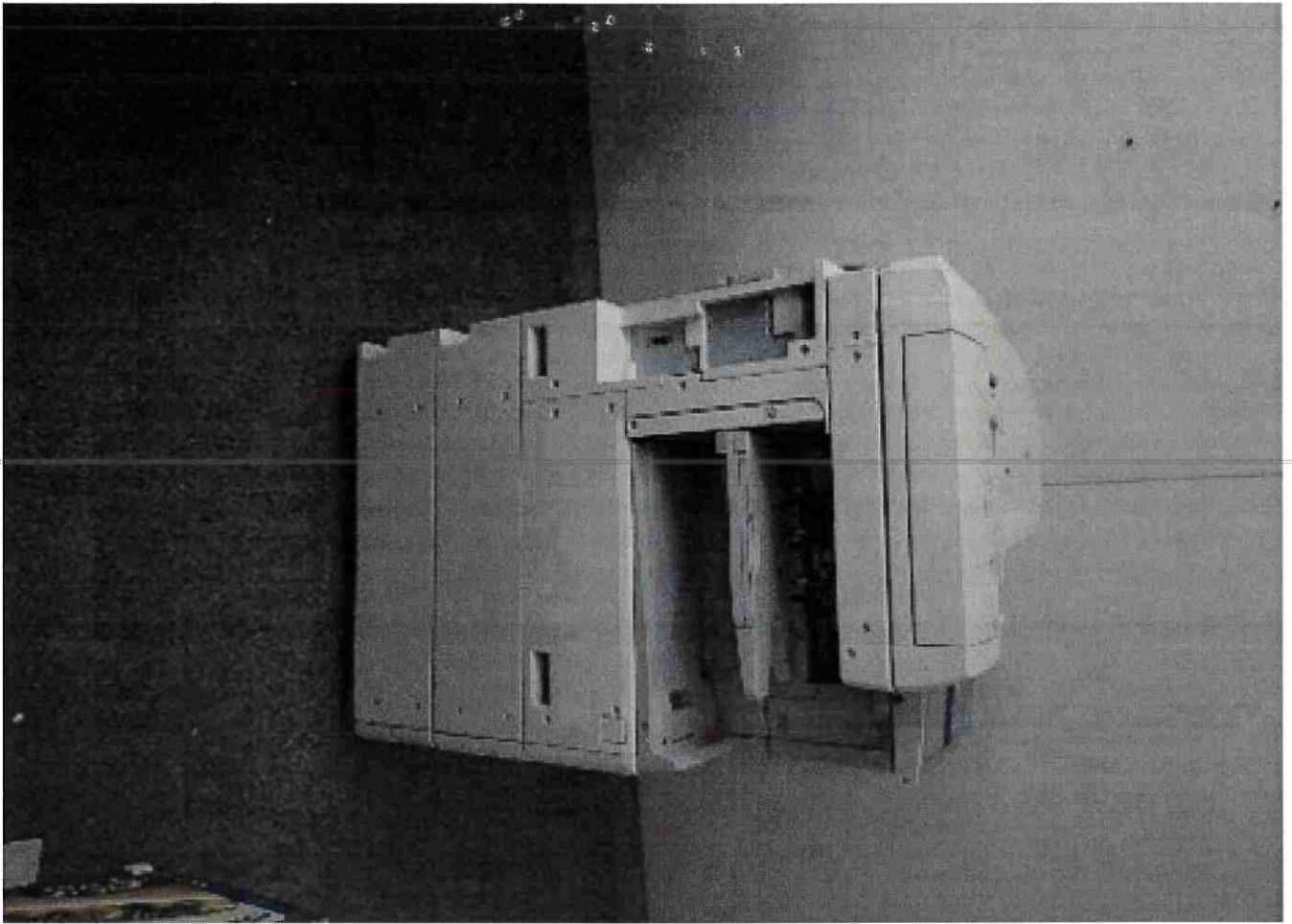






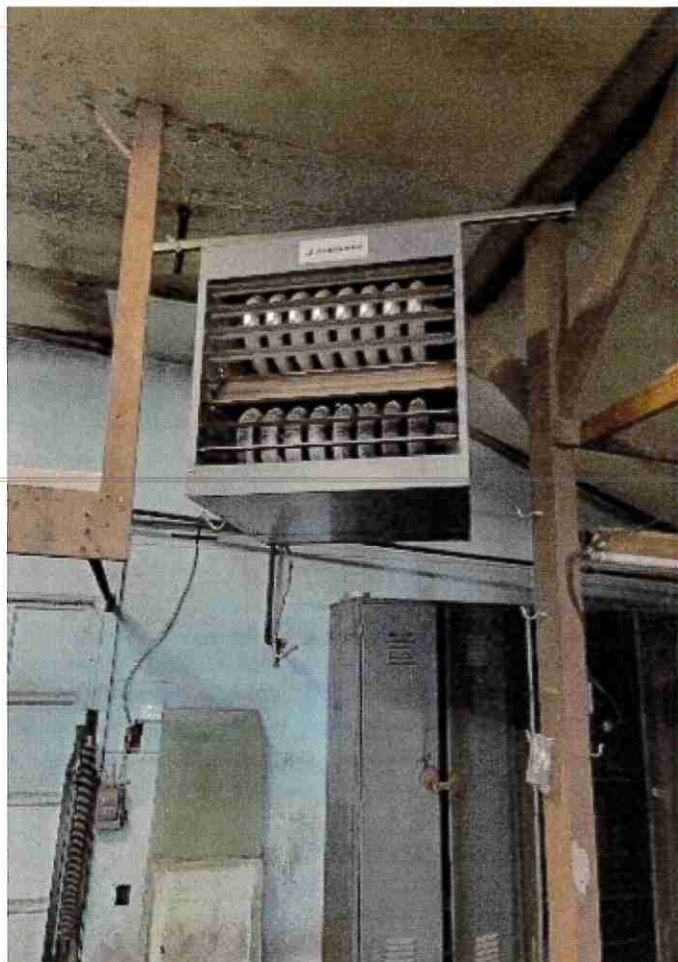




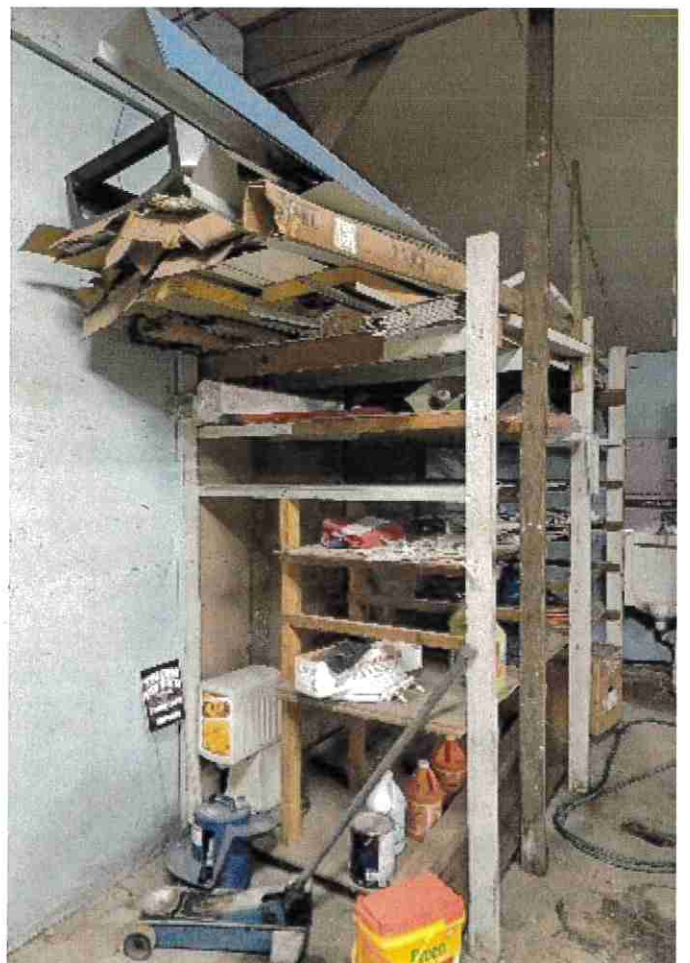




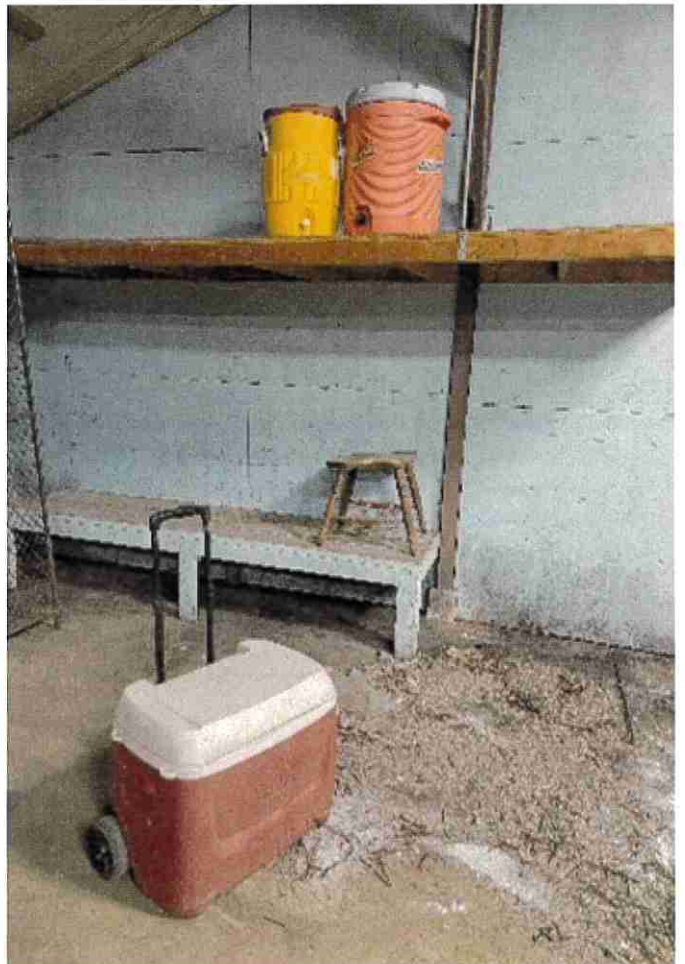
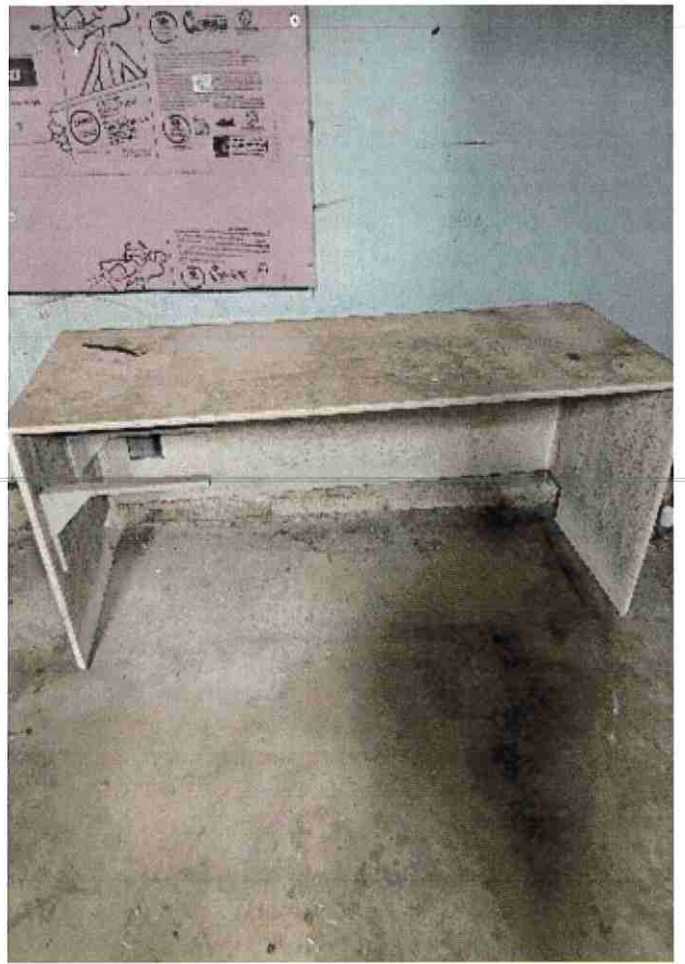
**EXHIBIT B: EAST SIDE PARK  
PARK DISTRICT GARAGE**







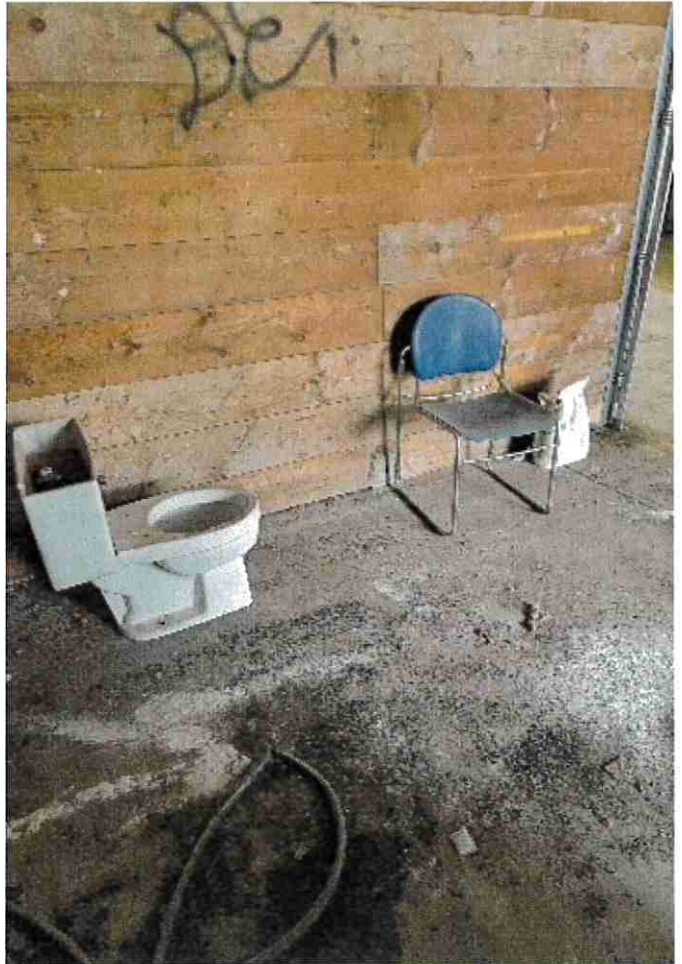

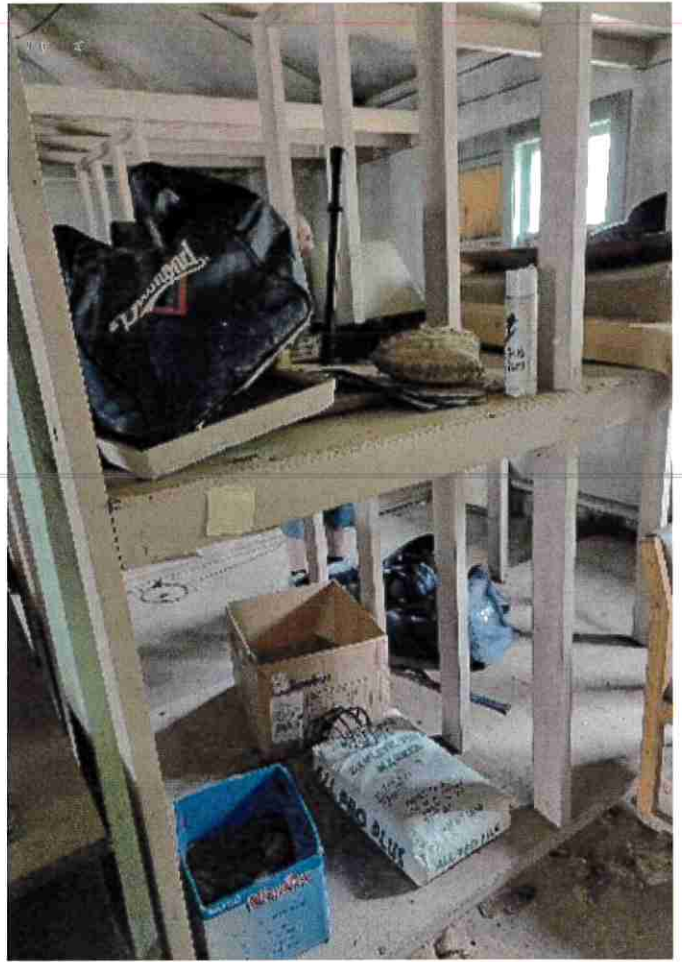
