**AN ORDINANCE DECLARING AS SURPLUS AND AUTHORIZING THE SALE OR
OTHER CONVEYANCE OR DISPOSAL OF SURPLUS PERSONAL PROPERTY OF
THE TOLONO PARK DISTRICT, CHAMPAIGN COUNTY, ILLINOIS**

WHEREAS, the Tolono Park District, Champaign County, State of Illinois ("Park District") is a duly organized and existing Park District created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Park District Code, and all laws amendatory thereof and supplementary thereto with full powers to enact ordinances for the benefit of the residents of the Park District and the Park District previously enacted the Park District Code; and

WHEREAS, the Tolono Park District, Champaign County, State of Illinois ("Park District") owns personal property used in connection with the operation of the Park District and described as follows:

WHEREAS, pursuant to Section 8-22 of the Park District Code (70 ILCS 1205/8-22) (“Code”) every park district is authorized to sell or convey any personal property that in the opinion of three-fifths of the members of the Board of Park Commissioners then holding office is no longer necessary, useful to, or for the best interests of the park district, in any manner that they may designate and with or without advertising; and

WHEREAS, the Board of Park Commissioners of the Park District (“Board”) has reviewed an itemized list and pictures attached hereto and incorporated herein as Exhibit A, find that the Property is no longer necessary, useful to or for the best interests of the Park District and recommending to sell or otherwise convey in the following manner: to trade, otherwise convey, or dispose.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Board of Park Commissioners of the Tolono Park District, Champaign County, Illinois, as follows:

Section 1: The Board finds that all of the recitals contained in the preamble to this Ordinance are true and correct and does hereby incorporate them in this Ordinance by this reference.

Section 2: The Board finds that the Property is no longer necessary, useful to or for the best interests of the Park District and declares it to be for the best interests of the Park District and its residents to dispose of in the following manner: by trade in subject to the execution by the purchaser of an appropriate instrument whereby the purchaser acknowledges that the purchaser is purchasing the Property used, as is, without any warranties of any kind whatsoever, assumes all liabilities in connection with the Purchaser’s use of the Property, and releases, indemnifies and holds harmless the Park District and its park commissioners, officers and employees against and from any and all such liabilities or by trade in, or disposal.

Section 3: The Board authorizes and directs the President of the Park District to take such action necessary to sell, or otherwise convey or dispose of the Property as herein authorized.

Section 4: This Ordinance shall be in full force and effect after its adoption as provided by law.
