

ORDINANCE NO. 23-7

TAX LEVY ORDINANCE FOR THE
TOLONO PARK DISTRICT IN CHAMPAIGN COUNTY, ILLINOIS
FOR 2023-2024

WHEREAS, the Board of Commissioners of the Tolono Park District in Champaign County, Illinois, did, on the 10th day of July, A.D. 2023, pass the Combined Budget and Appropriation Ordinance of the Tolono Park District in Champaign County, Illinois for the fiscal year beginning on the 1st day of May, A.D. 2023 and ending on the 30th day of April, A.D. 2024 after due Notice and hearing.

WHEREAS, it is necessary in order to meet and defray all the necessary expenses and liabilities of said Park District as required by statute or voted by the people in accordance with law, the Commissioners do hereby find and declare that there will be required to be raised by general taxation the amounts hereinafter set forth.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSIONERS OF THE TOLONO PARK DISTRICT IN CHAMPAIGN COUNTY, ILLINOIS:

Section 1: That there be, and there is hereby, levied and assessed upon all the taxable property subject to taxation within the corporate limits of said Park District for the revenue year A.D. 2023-2024, the total sum of \$206,850.50 for the following specific purposes, and in the respective sums as follows, to-wit:







TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE
(TAX YEAR 2023 LEVY)

I, the undersigned, hereby certify that I am the presiding officer of the Tolono Park District in Champaign County, Illinois, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.
